# 9. Matters for further discussion from the meeting same morning between the Executive and observers

As for our Nordic Congresses the NFGP Board should discuss if our future congresses mainly should be with focus on participation from the Nordic Countries or if we wish to expand? Would we be interested in hosting large Nordic congresses with up to maybe 2000 participants (with e.g. half of the participants coming from outside the Nordic countries)?

- Larger congresses (with lager venues and more hotel rooms booked) could give a higher economical risk for the host organizing country.
- In order to attract more non-Nordic participants, the organizer will have to accept more non-Nordic abstracts (which could result in a lower quality of the Scientific program).
- A larger congress demands more work / manpower to handle abstract, registrations, inquiries and questions (e.g. for WONCA Europe in 2016 with around 3000 paying participants, we received almost 1800 abstract).
- But most important maybe, would we like to keep the "Nordic touch and spirit" of our congresses (where of course both speakers and participants from outside the Nordic countries are very welcome to join), or will we aim at creating a new European congress?
